Pursuant to ARS 16-602 Pima County conducted a hand count of ballots after the recent November 7, 2006 General Election.

Per statute the Pima County Political Party Chairs for the Democrat, Republican and Libertarian parties met on November 8 and randomly selected the precincts and contests subject to be hand counted.

On November 10 and 11 designees of the county political parties met and conducted a hand count of the pertinent contested races and one statewide ballot proposition. This manual count included ballots cast at the polls as well as ballots cast through the early ballot process.

A table depicting the outcome of the manual audit is attached for your review. Please note that the audit did note some differences between the electronic count and the manual count. However, these differences were within the designated margins established by the Vote County Verification Committee.
