Pursuant to Arizona Revised Statutes § 19-111, attached hereto is the full text, in no less than eight point type, of the MEASURE or CONSTITUTIONAL AMENDMENT (circle appropriate word) intended to be INITIATED or REFERRED (circle appropriate word) at the next general election.

The Arizona Used car Lemon Law will require private sales, buy here pay here dealerships, and used car dealerships to guarantee the vehicle for the life of the loan of the vehicle and if the vehicle is bought outright with no finance the guarantee is a minimum of three years. Therefore, any mechanical failure is at the expense of the original owner. However, the buyer must keep complete maintenance logs on the vehicle to ensure that proper maintenance has been kept on the vehicle.

PROPOSING AN INITIATIVE TO THE CONSTITUTION OF ARIZONA: INITIATING THE USED CAR LEMON LAW.

Be it resolved by the Used Car Lemon Law Committee concurring:

1. The Used Car Lemon Law proposed initiative as follows if approved by the voters and on proclamation of the Governor.
3. The Arizona Used Car Lemon Law propose an initiative that will safe guard low income families, families with credit restrictions, and individuals that purchase used vehicle to have confidence that the vehicle will be in good working condition.
4. The Used Car Lemon Law will provide the buyer recourse and support in the event the vehicle has a major mechanical failure. In the event of a mechanical failure:
 - a. The original owner/ dealership repairs the vehicle at their expense
 - i. The original owner/ dealership cannot devalue the vehicle while making these repairs, thus no added mileage on the vehicle or used parts
 - b. The original owner/ dealership repays the customer 30% of money paid into the car via down payment, car payment or purchase out right
 - c. Replace the original purchased vehicle with a similar used vehicle only if buyer agrees on the replacement vehicle being acceptable.
2. The Secretary of State shall submit this initiative to the voters at the next general election as provided by article XXI, Constitution of Arizona.
