Chair Morrell noted the thresholds as they are currently set.

- 3 votes or 1% of early ballots, whichever is greater
- 3 votes or 1% of polling place ballots, whichever is greater

Co-Chair Valenzuela noted previous reduction did not lead to any observed harm. He noted 2025 brought some 1% range, but that proceedings went well. The Chair noted she was excited to see the reports.

Chair Morrell motioned to maintain the current set margins. Ms. Custis seconded the motion, and the motion was carried unanimously.

Mr. Esler Musta, Elections Director, Coconino County Elections Department, asked for clarification regarding the 3 vote margin, wanting to know if it was an absolute determination regarding the difference between batch and cumulative reporting. Co-Chair Valenzuela stated it represented both the batch and the cumulative early vote totals. The Chair noted it was a good question for discrepancy between 3 votes and the percentage of the sample size, which is overall indicates the threshold set for discrepancies.
