<b>GOVERNOR'S TRANSPORTATION VISION 21 TASK FORCE</b>			
The Governor's Transportation Vision 21 Task Force consists of members appointed by the Governor and to serve at the pleasure of the Governor. The Task Force will include the Director of the Arizona Department of Transportation and at-large members representing the business community, the general public and other diverse parties interested in the improvement of Arizona's transportation system.			
The Task Force will identify critical, long range transportation needs in both rural and urban areas of this state. Preliminary estimates of the longer-term (minimum of 20 years) cost of implementing a comprehensive, multimodal, long range transportation system plan will be developed and compared to estimated revenues from existing federal, state, and local transportation funding streams. Guidelines and procedures for prioritizing Arizona's transportation needs and expenditures will be studied and recommendations will be made. Executive Order 99-2.
