The Department intends to repeal or renumber R15-2-947 and R15-2-1131 through R15-2-1148 and incorporate the substance of the rules into new Articles that will be exempted from the numbering requirements in R15-2-101. This change will allow the Department to make long confusing rules into short rules that are clear and concise. The Department will also amend the rules to make them more clear, concise, and understandable and to incorporate legislative changes.
