2. **The subject matter of the proposed rule:**
The Department intends to promulgate new rules for a water quality consumer confidence report (CCR). The United States Environmental Protection Agency (EPA) has published final regulations that require each community water system (CWS) to provide its customers with an annual CCR. These regulations amend the National Primary Drinking Water Regulations (NPDWR), Part 141 and regulations for implementation of the NPDWR, Part 142. The rules will require that the CCR contains information regarding the level of contaminants in the water including: the source of the water supply; health information regarding contaminants; definitions for maximum contaminant level (MCL) goals and maximum contaminant levels; information on violations of MCLs and exceedance of action levels for regulated contaminants; an explanation of the violation, including the length of potential health

effects, and the actions taken by the system to address the violation; and information on unregulated contaminants radon, cryptosporidium, lead, and copper. Additional information may be contained in the CCR.

A Notice of Docket Opening was previously published regarding this rulemaking at 5 A.A.R. 4583. The Department has since determined that no changes will be made to Article 1 in this rulemaking, so Article 1 has been removed from this Notice of Docket Opening.
