

**EXECUTIVE ORDERS, PROCLAMATIONS OF  
GENERAL APPLICABILITY, AND STATEMENTS  
ISSUED BY THE GOVERNOR  
PURSUANT TO A.R.S. § 41-1013(B)(3)**

The Administrative Procedure Act (APA) requires the full-text publication of all Executive Orders and Proclamations of General Applicability issued by the Governor. In addition, the *Register* shall include each statement filed by the Governor in granting a commutation, pardon or reprieve, or stay or suspension of execution where a sentence of death is imposed.

**EXECUTIVE ORDER 2000-9**

**To Allocate Funds to Ensure Continuation of  
Wee Care Center for Sick Children**

**WHEREAS**, the Wee Care Center for Sick Children at John C. Lincoln Hospital – Deer Valley has been providing care to sick children of working families since 1990 through a staff of certified nursing assistants and registered nurses; and

**WHEREAS**, the Center has provided services to families in excess of 3,000 times annually, referring children, as appropriate, to John C. Lincoln Hospital adjacent to the Center; and

**WHEREAS**, the building that houses the Center is being sold and the Center is no longer able to maintain its “rent-free” status; and

**WHEREAS**, recent cuts to funding at John C. Lincoln Hospital preclude continued subsidization of the Center; and

**WHEREAS**, the Center has increased its fees to parents to help cover the increased costs and loss of revenue; and

**WHEREAS**, the business community has already agreed to assist in providing additional support to the Center by subsidizing increased fees for the program for their employees; and

**WHEREAS**, the increased fees will make it cost-prohibitive for lower-income parents and for those who are not employed by one of the companies providing subsidies; and

**WHEREAS**, during the 1997 First Regular Session of the Forty-third Legislature, the Health Crisis Fund was established, authorizing the Governor to expend funds in order to respond to an existing health crisis;

**NOW, THEREFORE**, I, Jane Dee Hull, Governor of the State of Arizona, by virtue of the authority vested in me by the Constitution and Laws of the State, do hereby declare a health crisis or a significant potential for a health crisis in this State and hereby,

1. Allocate such funds as necessary, not to exceed \$30,000 from the Health Crisis Fund as established pursuant to A.R.S. § 36-797 to the Department of Health Services, to be distributed on an as-needed basis, for the continuation of the Wee Care Center at John C. Lincoln Hospital – Deer Valley.
2. Direct the Department of Health Services to report the expenditures made by the Wee Care Center to the Joint Legislative Oversight Committee on the Tobacco Tax and Health Care Fund pursuant to A.R.S. § 336-797.

**EXECUTIVE ORDER 2000-11**

**To Allocate Funds to Ensure Continuation of  
the Crossroads Mission Detoxification Program**

**WHEREAS**, since 1996 the Crossroads Mission has operated the only detoxification program for drug and alcohol rehabilitation in Western Arizona, including Yuma, La Paz and Mohave Counties; and

**WHEREAS**, Tobacco Tax funds are now matched by funds from the City of Yuma and Yuma County, and supplemented by payments from individuals in the program, the Regional Behavioral Health Authority, and probation services; and

**WHEREAS**, the Crossroads Mission detoxification program has served 1,170 men and women since 1996; and

**WHEREAS**, Legislature had funded this program from Tobacco Tax funds since 1996 and did not continue funding during the 2000 legislative session, thereby eliminating the primary funding source of the program and jeopardizing the ability to provide detoxification services in Western Arizona, which may create a health crisis for substance abusers and the communities in which they live; and

**WHEREAS**, during the 1997 First Regular Session of the Forty-third Legislature, the Health Crisis Fund was established, authorizing the Governor to expend funds in order to respond to an existing health crisis;

**NOW, THEREFORE**, I, Jane Dee Hull, Governor of the State of Arizona, by virtue of the authority vested in me by the Constitution and Laws of the State, do hereby declare a health crisis or a significant potential for a health crisis in this State and hereby,

1. Allocate such funds as necessary, not to exceed \$250,000 from the Health Crisis Fund as established pursuant to A.R.S. § 36-797 to the Department of Health Services, to be distributed on an as needed basis as a one-time source of emergency funds to assist the Crossroads Mission Drug-Alcohol Rehabilitation Program in continuing to serve persons while the community secures a permanent source of funding. This one-time allocation from the Health Crisis Fund does not entitle Crossroads Mission to receive any future funding from the Health Crisis Fund for this program.
2. Direct the Department of Health Services to report expenditures made in support of this project to the Governor, and the Joint Legislative Oversight Committee on the Tobacco Tax and Health Care Fund pursuant to A.R.S. § 36-797.

**EXECUTIVE ORDER 2000-12**

**To Allocate Funds to Ensure Continuation of  
the Detoxification Center in Page, Arizona**

**WHEREAS**, since 1996 the Page Community Behavioral Health Detoxification Center has operated the only detoxification program for drug and alcohol rehabilitation in Northern Arizona; and

**WHEREAS**, the Page Community Behavioral Health Detoxification Center has served 6,796 men and women since 1996; and

**WHEREAS**, the Navajo Nation annually contributes \$106,000 to the operation of the Center; and

**WHEREAS**, the City of Page contributes to the operating budget, provides all police and emergency medical technician calls and transportation to the facility or hospital; and

**WHEREAS**, the Legislature had funded this program from Tobacco Tax funds since 1996 and did not continue the funding during the 2000 legislative session, thereby eliminating the primary funding source of the program and jeopardizing the ability to provide de-tox services in Northern Arizona, which may create a health crisis for substance abusers and the communities in which they live; and

**WHEREAS**, during the 1997 First Regular Session of the Forty-third Legislature, the Health Crisis Fund was established, authorizing the Governor to expend funds in order to respond to an existing health crisis;

**NOW, THEREFORE**, I, Jane Dee Hull, Governor of the State of Arizona, by virtue of the authority vested in me by the Constitution and Laws of the State, do hereby declare a health crisis or a significant potential for a health crisis in this State and hereby,

1. Allocate such funds as necessary, not to exceed \$250,000 from the Health Crisis Fund as established pursuant to A.R.S. § 36-797 to the Department of Health Services, to be distributed on an as needed basis as a one-time source of emergency funds to assist the Page Community Behavioral Health Detoxification Center in continuing to serve persons while the community secures a permanent source of funding. This one-time allocation from the Health Crisis Fund does not entitle the Page Community Behavioral Health Detoxification Center to receive any future funding from the Health Crisis Fund for this program.
2. Direct the Department of Health Services to report expenditures made in support of this project to the Governor, and the Joint Legislative Oversight Committee on the Tobacco Tax and Health Care Fund pursuant to A.R.S. § 36-797.

**EXECUTIVE ORDER 2000-13**

**To Allocate Funds to Ensure Continuation of  
Kidney Dialysis Services in the Rural Area of Eastern Pinal and Southern Gila Counties**

**WHEREAS**, the rural area of Eastern Pinal and Southern Gila Counties, especially the area between Kearny and San Manuel, has very limited health care services available and has been officially designated as a medically underserved area in this state; and

**WHEREAS**, there is a regional demand for kidney dialysis in that area, with the number of patients projected to be 41% higher in 2003 than in 1998; and

**WHEREAS**, kidney dialysis is a procedure performed on an individual with end stage renal disease three times a week for approximately four hours per session; and

**WHEREAS**, a large number of persons in the area must travel 75 or more miles each way for each treatment, with the recipients being frail or elderly; and

**WHEREAS**, such an arduous trip can be deleterious to the health of these individuals and can lead to health crises; and

**WHEREAS**, a feasibility study commissioned by Copper Communities Resource and Development, Inc. and completed by ESI Corporation of Phoenix concluded that there is sufficient demand in the area to allow for a financially viable kidney dialysis center; and

**WHEREAS**, BHP Copper has submitted to this state a letter of commitment to donate land to Copper Communities Resource and Development, Inc. in Mammoth, Arizona upon which a kidney dialysis center can be constructed; and

**WHEREAS**, county and local community leaders in that area have expressed a commitment to secure funding necessary in addition to that being provided through this Executive Order for construction and operation of a kidney dialysis center; and

**WHEREAS**, during the 1997 First Regular Session of the Forty-third Legislature, the Health Crisis Fund was established, authorizing the Governor to expend funds in order to respond to an existing health crisis;

**NOW, THEREFORE**, I, Jane Dee Hull, Governor of the State of Arizona, by virtue of the authority vested in me by the Constitution and Laws of the State, do hereby declare a health crisis or a significant potential for a health crisis in this State and hereby,

1. Allocate such additional funds as necessary, not to exceed \$250,000 from the Health Crisis Fund as established pursuant to A.R.S. § 36-797 to the Department of Health Services, to be placed in an account to be used to pay Copper Communities Resource and Development, Inc. for a portion of the costs of: 1) professional services required to complete pre-development activities and 2) the construction of a kidney dialysis center in Mammoth, Arizona. Examples of professional services are engineering, architectural design, and environmental assessments. Professional services do not include any administrative expenses of Copper Communities Resource and Development, Inc. No more than 40% of the funds may be used for pre-development activities. Release of any funds for the actual construction of the kidney dialysis center shall be contingent on Copper Communities Resource and Development, Inc. demonstrating to the satisfaction of the state that it has secured sufficient total funds to complete construction of the kidney dialysis center, and has met the deliverables identified by the Department. None of these funds shall be used for the purchase or lease of any land.
2. Direct the Department of Health Services to report monthly on the expenditure of funds from the account on activities related to pre-development and construction of a kidney dialysis center in Mammoth, Arizona to the Governor and the Joint Legislative Oversight Committee on the Tobacco Tax and Health Care Fund pursuant to A.R.S. § 36-797.
3. Any monies in the account that are unspent within eighteen months of the date of this executive order shall be returned to the state to be deposited in Medically Needy Account of the Tobacco Tax and Health Care Fund account established pursuant to A.R.S. § 36-774.

**EXECUTIVE ORDER 2000-14**

**To Allocate Funds to Ensure Continuation of  
Lions Camp Tatiyee in the White Mountains**

**WHEREAS**, the Lions Camp Tatiyee has provided physical and behavioral services to physically and mentally challenged individuals for 42 years; and

**WHEREAS**, the Camp Tatiyee experience last year enabled 461 participants to realize important social, behavioral and physical health goals and milestones;

**WHEREAS**, these experiences help reinforce and maintain developmental gains made during the academic year; and

**WHEREAS**, the time participants spend at Camp Tatiyee provides parents and caregivers with a critical period of respite; and

**WHEREAS**, the activities provided at Camp Tatiyee are vital to maintain participants' physical and behavioral health and well-being throughout the year; and

**WHEREAS**, without these reinforcing experiences and activities, physical and behavioral gains will be lost; and

**WHEREAS**, the funding from the Lions organization historically used for operations has been channeled for a land trade/purchase for the camp, seriously curtailing the Lions' ability to fundraise for operations; and

**WHEREAS**, the surrounding community has maximized its own emergency support for the facility; and

**WHEREAS**, without additional bridge funding Camp Tatiyee's continued existence is seriously in question; and

**WHEREAS**, Camp Tatiyee is the only facility in the region providing these services to the physically and mentally challenged; and

**WHEREAS**, the closure of Camp Tatiyee would jeopardize the continued development and well-being of hundreds of physically and mentally challenged individuals; and

**WHEREAS**, during the 1997 First Regular Session for the Forty-third Legislature, the Health Crisis Fund was established, authorizing the Governor to expend funds in order to respond to an existing health crisis;

**NOW, THEREFORE**, I, Jane Dee Hull, Governor of the State of Arizona, by virtue of the authority vested in me by the Constitution and Laws of the State, do hereby declare a health crisis or a significant potential for a health crisis in this State and hereby,

1. Allocate such funds as necessary, not to exceed \$50,000 from the Health Crisis Fund as established pursuant to A.R.S. § 36-797 to the Department of Health Services, to be distributed on an as-needed basis, for the continuation of the Lions Camp Tatiyee.
2. Direct the Department of Health Services to report the expenditures made by the Lions Camp Tatiyee to the Joint Legislative Oversight Committee on the Tobacco Tax and Health Care Fund pursuant to A.R.S. § 336-797.
