The proposed rule was an interim rule authorized at Laws 1997, Chapter 287, §§ 56(B) and (C) and was exempt from Title 41, Chapter 6, Article 3. As required under the session law, the Department submitted the interim rule for publication in the *Register* and provided 60 days after publication for public comment. No public comments were received. The rule, however, was never submitted for review and approval by the Attorney General pursuant to A.R.S. § 41-1044 and, thus, never became effective.
