

**Deadlines for Publication and G.R.R.C. Schedule**

**Effective Dates**

**A.R.S. § 41-1032(A), as amended by Laws 2002, Ch. 334, § 8 (effective August 22, 2002), states that a rule generally becomes effective 60 days after the day it is filed with the Secretary of State's Office. The following table lists filing dates and effective dates for rules that follow this provision.**

***Register Deadlines***

The Secretary of State's Office publishes the *Register* weekly. There is a three-week turnaround period between a deadline date and the publication date of the *Register*. The weekly deadline dates and issue dates are shown below. **Council meetings and *Register* deadlines do not correlate.** Also listed are the earliest dates on which a public hearing can be held on proposed rulemakings or proposed delegation agreements following publication of the notice of the public hearing in the *Register*.
