The Department of Environmental Quality (the Department) announces its final Annual Fee Schedule that applies to Aquifer Protection permit actions during FY2004 (July 1, 2003 through June 30, 2004). As required in A.R.S. §§ 49-241(E) and 49-241.02, and in accordance with R18-14-104, the Department proposed the following Annual Fee Schedule in the *Arizona Administrative Register* on March 21, 2003 (9 A.A.R. 1012, March 21, 2003). The Department received no comments on the proposed notice and therefore made no changes to the Annual Fee Schedule. The following table contains the final Annual Fee Schedule for FY2004. The Annual Fee Schedule applies for the review of applications for individual aquifer protection permits (APP), amendments to existing APPs, and clean closure approvals from July 1, 2003 through June 30, 2004. The hourly rate applies to review hours incurred by Department staff for a particular permit action. The maximum fees apply to any application that is deemed administratively complete during the specified time-frame.
