

Introduction

The Secretary of State's Office is required to publish a semiannual index to the *Register* under the Arizona Administrative Procedure Act. A.R.S. § 41-1013(A) states, "The secretary of state shall publish the register at least once each month including the information which is provided under subsection B of this section and which is filed with the secretary of state during the preceding thirty days. The secretary of state shall publish an index to the register at least twice each year." This index covers material published in the *Register* from January 1 to June 30, 2005.
