Subsection R4-23-202(A)(2) cites A.R.S. § 32-1922(C) in relation to eligibility to obtain pharmacist licensure by examination, but A.R.S. § 32-1922(C) actually refers to the Board's ability to grant licensure without an examination when the other jurisdiction that licenses the pharmacist provides reciprocal licensure to Arizona pharmacists. The correct citation is A.R.S. § 32-1922(D). The proposed rule will change the citation from 32-1922(C) to 32-1922(D). The rules will include format, style, and grammar necessary to comply with the current rules of the Secretary of State and Governor's Regulatory Review Council.
