The Department proposes amendments to the language of several existing rules in accordance with Laws 2007, Ch. 240, § 10(B), which requires the director of water resources to amend the rules adopted to implement A.R.S. § 45-108 to include: (1) criteria for making determinations pursuant to section 45-108.03; and (2) criteria for demonstrating a physically available 100-year supply of groundwater or stored water to be recovered outside the area of impact in specific aquifer systems and groundwater basins and subbasins outside of active management areas.

The Department may consider additional rule amendments as necessary to implement Laws 2007, Ch. 240 that may include repealing, renumbering and amending sections as well as adding new sections.
