2. The public information relating to the listed Article:

Laws 2014, Ch. 233, effective July 24, 2014, provided a new definition for behavioral health services and amended the definition of health care institution to include facilities that provide behavioral health services. Laws 2014, Ch. 233 also provided the Department with exempt rulemaking authority to amended rules in 9 A.A.C. 10. After receiving an exception from the Governor's rulemaking moratorium, established by Executive Order 2012-03, the Department has drafted amendments to Article 1 General and Article 10 Outpatient Treatment Centers, and has drafted a new Article 19, Counseling Facilities to comply with Laws 2014, Ch. 233. The Department posted the draft rules for public comment on October 14, 2014. The draft rules are being made available to allow interested persons an opportunity to provide comments on the draft rules.
