CHAPTER 26

SENATE BILL 1147

AN ACT

AMENDING SECTIONS 20-342 AND 20-382, ARIZONA REVISED STATUTES; RELATING TO
 OPEN COMPETITION INSURANCE RATES.

1 Be it enacted by the Legislature of the State of Arizona:

2 Section 1. Section 20-342, Arizona Revised Statutes, is amended to
 3 read:

4 20-342. Scope and application of article; definition

5 A. Nothing contained in this article shall apply to:

6 1. Life insurance.

7 2. Disability insurance.

8 3. Reinsurance, except joint reinsurance as provided in section
 9 20-369.

10 4. Insurance against loss of or damage to aircraft, their hulls,
 11 accessories and equipment, or against liability, other than employers'
 12 liability, arising out of the ownership, maintenance or use of aircraft.

13 5. Insurance of vessels or craft, their cargoes, marine builders'
 14 risks, marine protection and indemnity, or other risks commonly insured under
 15 marine, as distinguished from inland marine, insurance policies.

16 B. Rates for the types of insurance included in section 20-382 are
 17 only subject to sections 20-381 through 20-399.

18 C. This section and sections 20-341 and 20-356 through 20-374 apply
 19 to risks subject to section 20-360, ~~medical malpractice insurance~~, workers'
 20 compensation and employers' liability insurance incident to and written in
 21 connection with workers' compensation on risks or operations in this state.

22 D. This section and sections 20-341 and 20-361 through 20-379 shall
 23 apply to title insurance on risks located in this state and to escrow

1 services performed by a title insurer or title insurance agent as defined in
2 section 20-1562. Such sections are designated as the title insurance rate
3 regulatory provisions of this article and are the only sections of this
4 article which apply to title insurance.

5 E. In this article, "workers' compensation rates" means rates for
6 workers' compensation and employers' liability insurance incident to and
7 written in connection with workers' compensation.

8 Sec. 2. Section 20-382, Arizona Revised Statutes, is amended to read:
9 20-382. Scope of application

10 A. This article applies to all insurance on risks or on operations in
11 this state, except:

12 1. Reinsurance, other than joint reinsurance to the extent stated in
13 section 20-391.

14 2. Any policy of insurance against loss or damage to or legal
15 liability in connection with property located outside this state, any motor
16 vehicle or aircraft principally garaged and used outside this state or any
17 activity wholly carried on outside this state.

18 3. Insurance of vessels or craft, their cargoes, marine builders'
19 risks, marine protection and indemnity or other risks commonly insured under
20 marine, as distinguished from inland marine, insurance policies.

21 4. Disability or life insurance.

22 5. Annuities.

23 6. Mortgage guaranty insurance.

24 7. Workers' compensation and employers' liability insurance written
25 in connection with workers' compensation.

26 8. Risks subject to section 20-360.

27 ~~9. Medical malpractice insurance.~~

28 ~~10.~~ 9. Title insurance.

29 B. This article does not apply to hospital service or medical service
30 corporations, investment companies, mutual benefit associations or fraternal
31 beneficiary associations.
