CHAPTER 151
SENATE BILL 1053

AN ACT

REPEALING SECTION 42-18109, ARIZONA REVISED STATUTES; AMENDING TITLE 42, CHAPTER 18, ARTICLE 3, ARIZONA REVISED STATUTES, BY ADDING A NEW SECTION 42-18109; RELATING TO TAX LIENS.

1 Be it enacted by the Legislature of the State of Arizona:

2 Section 1. Repeal

3 Section 42-18109, Arizona Revised Statutes, is repealed.

4 Sec. 2. Title 42, chapter 18, article 3, Arizona Revised Statutes, is
5 amended by adding a new section 42-18109, to read:

6 42-18109. Publication and posting of list and notice

7 A. THE COUNTY TREASURER SHALL POST A CORRECT COPY OF THE LIST AND
8 NOTICE UNDER SECTION 42-18106 NEAR THE OUTER DOOR OF THE OFFICE OF THE COUNTY
9 TREASURER. THE LIST AND NOTICE SHALL REMAIN POSTED FOR AT LEAST TWO WEEKS
10 BEFORE THE DATE OF THE SALE.

11 B. THE COUNTY TREASURER SHALL PUBLISH A CORRECT COPY OF THE LIST AND
12 NOTICE UNDER SECTION 42-18106 AT LEAST ONE TIME IN A NEWSPAPER OF GENERAL
13 CIRCULATION IN THE COUNTY. THE PUBLICATION SHALL BE AT LEAST TWO WEEKS BUT
14 NOT MORE THAN THREE WEEKS BEFORE THE DATE OF SALE STATED IN THE NOTICE.

15 C. THE NEWSPAPER THAT PRINTS THE LIST AND NOTICE UNDER SECTION
16 42-18106 SHALL ALSO POST THE LIST AND NOTICE FROM THE FIRST PUBLICATION DATE
17 THROUGH MARCH 1 OF THE CURRENT YEAR ON THE INTERNET ON A WEBSITE THAT POSTS
18 THE LEGAL NOTICES OF TEN OR MORE ARIZONA NEWSPAPERS.
