# HOUSE BILL 2471

AN ACT

AMENDING SECTION 9-511.03, ARIZONA REVISED STATUTES; RELATING TO MUNICIPAL  
GARBAGE SERVICE.

(TEXT OF BILL BEGINS ON NEXT PAGE)

1 Be it enacted by the Legislature of the State of Arizona:

2 Section 1. Section 9-511.03, Arizona Revised Statutes, is amended to  
3 read:

4 9-511.03. Outside waste or garbage collection services;  
5 requirements

6 A. If a city or town provides waste or garbage collection services  
7 outside of its boundaries, for those services the city or town shall:

8 1. Keep all records of the services separate from all other city or  
9 town municipal records.

10 2. Make an in-lieu contribution to all state, city, town, county and  
11 other taxing districts equal to the taxes that would be required of private  
12 garbage collection and disposal companies performing the same service.

13 3. Pay an in-lieu contribution to the recycling fund established by  
14 section 49-837 equal to the federal taxes that would be required of private  
15 garbage collection and disposal companies performing the same service.

16 4. Pay all fees and costs that are applicable to private companies  
17 including landfill fees.

18 5. Ensure that no city or town taxes, fees or revenues are used to  
19 subsidize the waste or garbage collection and disposal services outside the  
20 city or town.

21 B. This section does not restrict the ability of a city or town to  
22 enter into mutual aid or intergovernmental agreements with other cities or  
23 towns to respond to REQUESTS FOR emergency assistance.

24 C. ~~The provisions of~~ This section shall not apply to a city or town  
25 if all of the following apply:

26 1. The city or town provides waste or garbage collection services  
27 outside its ~~borders~~ BOUNDARIES in an unincorporated territory that is within  
28 three miles of its ~~borders~~ BOUNDARIES and within its municipal planning area  
29 as designated in the land use map of the municipality's general plan.

30 2. The city or town does not provide waste or garbage services in an  
31 incorporated area other than its own.

32 3. The city or town is located in a county with a population exceeding  
33 two million persons ~~according to the most recent decennial census~~ OR THE CITY  
34 OR TOWN HAS A POPULATION OF LESS THAN TWO THOUSAND FIVE HUNDRED PERSONS AND  
35 ALLOWS PRIVATE ENTERPRISE TO PROVIDE COMMERCIAL AND RESIDENTIAL WASTE OR  
36 GARBAGE COLLECTION SERVICES IN THE CITY OR TOWN.




HOUSE CONCURS IN SENATE  
AMENDMENTS AND FINAL PASSAGE






