SENATE BILL 1223

AN ACT

AMENDING SECTION 11-212, ARIZONA REVISED STATUTES; RELATING TO SUPERVISORIAL DISTRICTS.

1 Be it enacted by the Legislature of the State of Arizona:

2 Section 1. Section 11-212, Arizona Revised Statutes, is amended to
3 read:

4 11-212. Supervisory districts

5 The board of supervisors shall meet at the county seat on the ~~first~~
6 ~~regularly scheduled meeting in June~~ OR BEFORE DECEMBER 1 following the
7 release of the United States decennial census data and divide the county into
8 three or five supervisory districts as provided in this article, which
9 shall be numbered, respectively, districts one, two and three or districts
10 one, two, three, four and five. The board shall define the boundaries and
11 limits of each district and make the division equal or with not more than ten
12 per cent difference in population. The county may redistrict as often as
13 deemed necessary between each United States decennial census.

14 Sec. 2. Emergency

15 This act is an emergency measure that is necessary to preserve the
16 public peace, health or safety and is operative immediately as provided by
17 law.
