# HOUSE BILL 2485

AN ACT

MAKING APPROPRIATIONS TO THE DEPARTMENT OF ECONOMIC SECURITY FOR TRIBAL SENIOR CENTERS.

1 Be it enacted by the Legislature of the State of Arizona:

2 Section 1. Appropriations; purpose; exemption

3 A. The sum of \$714,300 is appropriated from the state general fund in  
4 each of fiscal years 2001-2002 and 2002-2003 to the department of economic  
5 security to be combined with matching funds from the Navajo Nation for  
6 planning, designing, developing and constructing senior center facilities for  
7 Navajo Nation chapters. The Navajo Nation shall develop a plan for the  
8 equitable use of the monies among the chapters to address the needs of up to  
9 one-half of the chapters in fiscal year 2001-2002 and the remaining chapters  
10 in fiscal year 2002-2003. Appropriated monies shall not be used for  
11 administrative costs.

12 B. The sum of \$285,700 is appropriated in each of fiscal years  
13 2001-2002 and 2002-2003 to the department of economic security to be combined  
14 with matching contributions from the Hopi Tribe for planning, designing,  
15 developing and constructing Hopi senior center facilities. Appropriated  
16 monies shall not be used for administrative costs.

17 C. The appropriations made in subsections A and B of this section are  
18 exempt from the provisions of section 35-190, Arizona Revised Statutes,  
19 relating to lapsing of appropriations, except that monies remaining  
20 unexpended and unencumbered on June 30, 2004 revert to the state general  
21 fund.
