# HOUSE BILL 2196

AN ACT

AMENDING SECTION 42-17103, ARIZONA REVISED STATUTES; RELATING TO COUNTY, CITY  
AND TOWN BUDGETS.

1 Be it enacted by the Legislature of the State of Arizona:

2 Section 1. Section 42-17103, Arizona Revised Statutes, is amended to  
3 read:

4 42-17103. Publication of estimates of expenses and notice of  
5 public hearing and special meeting

6 A. The governing body of each county, city or town shall publish the  
7 estimates of expenses, OR A SUMMARY OF THE ESTIMATE OF EXPENSES and a notice  
8 of a public hearing and special meeting of the governing body to hear  
9 taxpayers and make tax levies at designated times and places. THE SUMMARY  
10 SHALL SET FORTH SOURCES AND USES OF FUNDS, AND INCLUDE CONSOLIDATED REVENUES  
11 AND EXPENDITURES BY CATEGORY, DEPARTMENT AND FUND, TRUTH IN TAXATION  
12 CALCULATIONS, AND PRIMARY AND SECONDARY PROPERTY TAX LEVIES. A COMPLETE COPY  
13 OF THE ESTIMATE OF EXPENSES SHALL BE MADE AVAILABLE AT THE CITY, TOWN OR  
14 COUNTY LIBRARIES, AND CITY, TOWN OR COUNTY ADMINISTRATIVE OFFICES.

15 B. The estimates and notice shall be published once a week for at  
16 least two consecutive weeks after the estimates are tentatively adopted in  
17 the official newspaper of the county, city or town, if there is one, and, if  
18 not, in a newspaper of general circulation in the county, city or town.

19 C. If a truth in taxation notice and hearing is required under section  
20 42-17107, the governing body may combine the notice under this section with  
21 the truth in taxation notice.
