REPEALING SECTION 41-3002.18, ARIZONA REVISED STATUTES; AMENDING TITLE 41, CHAPTER 27, ARTICLE 2, ARIZONA REVISED STATUTES, BY ADDING SECTION 41-3012.01; RELATING TO THE ARIZONA BOARD OF REGENTS.

1 Be it enacted by the Legislature of the State of Arizona:

2 Section 1. Repeal

3 Section 41-3002.18, Arizona Revised Statutes, is repealed.

4 Sec. 2. Title 41, chapter 27, article 2, Arizona Revised Statutes, is  
5 amended by adding section 41-3012.01, to read:

6 41-3012.01. Arizona board of regents; conditional termination  
7 on July 1, 2012

8 SUBJECT TO APPROVAL BY THE VOTERS OF A CONSTITUTIONAL AMENDMENT  
9 REPEALING THE AUTHORITY FOR THE BOARD PURSUANT TO ARTICLE XI, SECTION  
10 5, CONSTITUTION OF ARIZONA:

11 1. THE ARIZONA BOARD OF REGENTS TERMINATES ON JULY 1, 2012.

12 2. TITLE 15, CHAPTER 13, ARTICLE 2 IS REPEALED ON JANUARY 1,  
13 2013.

14 Sec. 3. Purpose

15 Pursuant to section 41-2955, subsection B, Arizona Revised Statutes,  
16 the legislature continues the Arizona board of regents to adopt, prescribe  
17 and regulate administrative and financial policies applicable to universities  
18 of this state, to adopt regulations, rules and measures for universities of  
19 this state and to supervise the operation of universities of this state.

20 Sec. 4. Retroactivity

21 Sections 1 and 2 of this act are effective retroactively to July 1,  
22 2002.
