HOUSE BILL 2013

AN ACT

AMENDING SECTION 32-2526, ARIZONA REVISED STATUTES; RELATING TO THE JOINT BOARD ON THE REGULATION OF PHYSICIAN ASSISTANTS.

1 Be it enacted by the Legislature of the State of Arizona:

2 Section 1. Section 32-2526, Arizona Revised Statutes, is amended to
3 read:

4 32-2526. Fees

5 A. By a vote at its annual fall meeting, the board shall establish
6 nonrefundable fees and penalties that do not exceed the following:

7 1. PROCESSING AN application for a ~~regular~~ AN ACTIVE license, ~~one~~
8 FOUR hundred ~~twenty-five~~ dollars.

9 2. ISSUING AN ACTIVE LICENSE, FOUR HUNDRED DOLLARS.

10 ~~2.~~ 3. Application for a temporary license, fifty ONE HUNDRED dollars.

11 ~~3.~~ 4. Conversion from a temporary license to a regular license,
12 ~~seventy-five~~ THREE HUNDRED dollars.

13 ~~4.~~ 5. Annual renewal of a regular license, a fee of not to exceed ~~one~~
14 FOUR hundred dollars.

15 ~~5.~~ 6. Penalty fee for late renewal of a regular license, ~~one~~ THREE
16 hundred FIFTY dollars.

17 ~~6.~~ 7. Issuance of a duplicate license, twenty-five dollars.

18 ~~7.~~ 8. Approval of notification of supervision by a supervising
19 physician, ~~one hundred twenty-five~~ THREE HUNDRED FIFTY dollars.

20 ~~8.~~ 9. Application to transfer the responsibility of the supervising
21 physician to an approved supervising physician's agent, fifty TWO HUNDRED
22 dollars.

23 10. ADDING A SUPERVISING PHYSICIAN AGENT SUBSEQUENT TO THE APPROVED
24 NOTIFICATION OF SUPERVISION, TWENTY-FIVE DOLLARS.

25 11. VERIFICATION OF A LICENSE, TEN DOLLARS.

26 12. COPYING RECORDS, DOCUMENTS, LETTERS, MINUTES, APPLICATIONS AND
27 FILES, ONE DOLLAR FOR THE FIRST THREE PAGES AND TWENTY-FIVE CENTS FOR EACH
28 ADDITIONAL PAGE.

29 13. FOR THE SALE OF COMPUTERIZED TAPES OR DISKETTES THAT DO NOT REQUIRE
30 PROGRAMMING, ONE HUNDRED DOLLARS.

31 ~~9.~~ 14. For services not required to be provided by this chapter, but
32 which the board deems appropriate to carry out the intent and purpose of this
33 chapter, a fee of not to exceed the actual cost of providing the
34 services. Notwithstanding section 32-2506, the board shall deposit, pursuant
35 to sections 35-146 and 35-147, all of the monies collected under this
36 paragraph in the board of medical examiners' fund established by section
37 32-1406.

38 B. Notwithstanding subsection A of this section, on written request
39 the board may return the license renewal fee, ~~for~~ for good cause shown.

40 C. THE BOARD MAY COLLECT FROM A DRAWER OF A DISHONORED CHECK, DRAFT
41 ORDER OR NOTE AN AMOUNT ALLOWED PURSUANT TO SECTION 44-6852.

1 Sec. 2. Requirements for enactment; two-thirds vote

2 Pursuant to article IX, section 22, Constitution of Arizona, this act
3 is effective only on the affirmative vote of at least two-thirds of the
4 members of each house of the legislature and is effective immediately on the
5 signature of the governor or, if the governor vetoes this act, on the
6 subsequent affirmative vote of at least three-fourths of the members of each
7 house of the legislature.
