CHAPTER 90

HOUSE BILL 2293

AN ACT

AMENDING TITLE 28, CHAPTER 8, ARTICLE 4, ARIZONA REVISED STATUTES, BY ADDING SECTION 28-3168; RELATING TO DRIVER LICENSES.

1 Be it enacted by the Legislature of the State of Arizona:

2 Section 1. Title 28, chapter 8, article 4, Arizona Revised Statutes,
3 is amended by adding section 28-3168, to read:

4 28-3168. Driver license and nonoperating identification license
5 applications; selective service registration;
6 reimbursement

7 A. WHEN A MALE PERSON WHO IS UNDER TWENTY-SIX YEARS OF AGE APPLIES FOR
8 A DRIVER LICENSE OR A NONOPERATING IDENTIFICATION LICENSE OR FOR RENEWAL OF
9 A DRIVER LICENSE, THE PERSON CONSENTS TO REGISTER WITH THE SELECTIVE SERVICE
10 SYSTEM IN COMPLIANCE WITH SECTION 3 OF THE MILITARY SELECTIVE SERVICE ACT (50
11 UNITED STATES CODE APPENDIX SECTION 453).

12 B. DRIVER LICENSE APPLICATIONS, DRIVER LICENSE RENEWAL APPLICATIONS
13 AND NONOPERATING IDENTIFICATION LICENSE APPLICATIONS, INCLUDING ELECTRONIC
14 APPLICATIONS, SHALL CONTAIN THE FOLLOWING STATEMENT:

15 BY SUBMITTING THIS APPLICATION, I CONSENT TO REGISTRATION
16 WITH THE SELECTIVE SERVICE SYSTEM IF I AM REQUIRED TO REGISTER
17 UNDER FEDERAL LAW. IF I AM UNDER EIGHTEEN YEARS OF AGE, I
18 UNDERSTAND THAT I WILL BE REGISTERED AS REQUIRED BY FEDERAL LAW
19 WHEN I BECOME EIGHTEEN YEARS OF AGE.

20 C. THE APPLICANT'S SUBMISSION OF THE APPLICATION SHALL SERVE AS AN
21 INDICATION THAT THE APPLICANT HAS ALREADY REGISTERED WITH THE SELECTIVE
22 SERVICE SYSTEM OR THAT THE APPLICANT IS AUTHORIZING THE DEPARTMENT TO FORWARD
23 THE NECESSARY INFORMATION FOR REGISTRATION TO THE SELECTIVE SERVICE SYSTEM.

24 D. THE DEPARTMENT SHALL FORWARD IN AN ELECTRONIC FORMAT THE NECESSARY
25 PERSONAL INFORMATION REQUIRED FOR REGISTRATION OF APPLICANTS DESCRIBED IN
26 SUBSECTION A TO THE SELECTIVE SERVICE SYSTEM.

27 E. THE DEPARTMENT SHALL NOT IMPLEMENT THIS SECTION UNLESS THE
28 SELECTIVE SERVICE SYSTEM PROVIDES ADEQUATE FUNDING TO THE DEPARTMENT TO COVER
29 THE COSTS THE DEPARTMENT WILL INCUR IN IMPLEMENTING THIS SECTION.

30 Sec. 2. Effective date

31 Section 28-3168, Arizona Revised Statutes, as added by this act, is
32 effective from and after December 31, 2003.
