# SENATE BILL 1414

AN ACT

RELATING TO GENERAL REVENUE FUNDING.

1 Be it enacted by the Legislature of the State of Arizona:

2 Section 1. Lottery deposits

3 Notwithstanding section 5-505, subsection B, Arizona Revised Statutes,  
4 for fiscal year 2004-2005 not less than 31.6 per cent of the total annual  
5 revenues accruing from the sale of multistate lottery tickets shall be  
6 deposited in the state lottery fund established by section 5-521, Arizona  
7 Revised Statutes, to be used as prescribed in section 5-522, Arizona Revised  
8 Statutes, including deposits to the state general fund pursuant to section  
9 5-522, subsection F, Arizona Revised Statutes.

10 Sec. 2. Unrestricted federal grant monies

11 Any unrestricted federal monies received May 1, 2004 through June 30,  
12 2005 shall be deposited in the state general fund. The monies shall be used  
13 for the payment of essential governmental services.

14 Sec. 3. Retroactivity

15 Section 2 of this act, relating to unrestricted federal grant monies,  
16 is effective retroactively to from and after April 30, 2004.
