AN ACT

REPEALING SECTION 41-3004.08, ARIZONA REVISED STATUTES; AMENDING TITLE 41, CHAPTER 27, ARTICLE 2, ARIZONA REVISED STATUTES, BY ADDING SECTION 41-3014.01; RELATING TO THE DEPARTMENT OF COMMERCE.

1 Be it enacted by the Legislature of the State of Arizona:

2 Section 1. Repeal

3 Section 41-3004.08, Arizona Revised Statutes, is repealed.

4 Sec. 2. Title 41, chapter 27, article 2, Arizona Revised Statutes, is
5 amended by adding section 41-3014.01, to read:

6 41-3014.01. Department of commerce; termination July 1, 2014

7 A. THE DEPARTMENT OF COMMERCE, EXCEPT THE SOLAR ENERGY ADVISORY
8 COUNCIL AND THE STATE ENERGY CODE ADVISORY COMMISSION, TERMINATES ON JULY 1,
9 2014.

10 B. TITLE 41, CHAPTER 10, EXCEPT SECTIONS 41-1510 AND 41-1511, IS
11 REPEALED ON JANUARY 1, 2015.

12 Sec. 3. Purpose

13 Pursuant to section 41-2955, subsection B, Arizona Revised Statutes,
14 the legislature continues the department of commerce in order to encourage
15 the orderly planning and stimulation of economic activity in this state.

16 Sec. 4. Retroactivity

17 Sections 1 and 2 of this act are effective retroactively to July 1,
18 2004.
