HOUSE BILL 2233

AN ACT

AMENDING TITLE 20, CHAPTER 11, ARTICLE 1, ARIZONA REVISED STATUTES, BY ADDING SECTION 20-2113.01; RELATING TO CONSUMER REPORTING AGENCIES.

1 Be it enacted by the Legislature of the State of Arizona:

2 Section 1. Title 20, chapter 11, article 1, Arizona Revised Statutes,
3 is amended by adding section 20-2113.01, to read:

4 20-2113.01. Consumer reporting agency; sale of information
5 obtained by insurance inquiry prohibited;
6 exceptions

7 A. A CONSUMER REPORTING AGENCY SHALL NOT PROVIDE OR SELL DATA OR LISTS
8 THAT INCLUDE ANY INFORMATION THAT IN WHOLE OR IN PART WAS SUBMITTED IN
9 CONJUNCTION WITH AN INSURANCE INQUIRY ABOUT A CONSUMER'S CREDIT INFORMATION
10 OR A REQUEST FOR A CREDIT REPORT OR INSURANCE SCORE. SUCH INFORMATION
11 INCLUDES THE EXPIRATION DATES OF AN INSURANCE POLICY OR ANY OTHER INFORMATION
12 THAT MAY IDENTIFY TIME PERIODS DURING WHICH A CONSUMER'S INSURANCE MAY EXPIRE
13 AND THE TERMS AND CONDITIONS OF THE CONSUMER'S INSURANCE COVERAGE.

14 B. SUBSECTION A DOES NOT APPLY TO DATA OR LISTS THAT THE CONSUMER
15 REPORTING AGENCY SUPPLIES TO THE INSURANCE PRODUCER FROM WHOM THE INFORMATION
16 WAS RECEIVED, THE INSURER ON WHOSE BEHALF THE PRODUCER ACTED OR THE INSURER'S
17 AFFILIATES OR HOLDING COMPANIES.

18 C. THIS SECTION SHALL NOT RESTRICT AN INSURER FROM BEING ABLE TO
19 OBTAIN A CLAIMS HISTORY REPORT OR A MOTOR VEHICLE REPORT.
