REPEALING SECTION 41-3004.16, ARIZONA REVISED STATUTES; AMENDING TITLE 41, CHAPTER 27, ARTICLE 2, ARIZONA REVISED STATUTES, BY ADDING SECTION 41-3009.04; RELATING TO THE GOVERNOR'S COUNCIL ON DEVELOPMENTAL DISABILITIES.

1 Be it enacted by the Legislature of the State of Arizona:

2 Section 1. Repeal

3 Section 41-3004.16, Arizona Revised Statutes, is repealed.

4 Sec. 2. Title 41, chapter 27, article 2, Arizona Revised Statutes, is
5 amended by adding section 41-3009.04, to read:

6 41-3009.04. Governor's council on developmental disabilities;
7 termination July 1, 2009

8 A. THE GOVERNOR'S COUNCIL ON DEVELOPMENTAL DISABILITIES TERMINATES ON
9 JULY 1, 2009.

10 B. TITLE 41, CHAPTER 22 IS REPEALED ON JANUARY 1, 2010.

11 Sec. 3. Purpose

12 Pursuant to section 41-2955, subsection B, Arizona Revised Statutes,
13 the legislature continues the governor's council on developmental
14 disabilities to fulfill the duties prescribed in section 41-2454, Arizona
15 Revised Statutes.

16 Sec. 4. Retroactivity

17 Sections 1 and 2 of this act are effective retroactively to July 1,
18 2004.
