HOUSE BILL 2620

AN ACT

AMENDING SECTION 38-519, ARIZONA REVISED STATUTES; RELATING TO THE
LEGISLATIVE ETHICS COMMITTEE.

1 Be it enacted by the Legislature of the State of Arizona:

2 Section 1. Section 38-519, Arizona Revised Statutes, is amended to
3 read:

4 38-519. Ethics committee; membership; powers and duties; code
5 of ethics

6 A. An ethics committee is established in the senate and an ethics
7 committee is established in the house of representatives, each consisting of
8 five members. The president of the senate and the speaker of the house of
9 representatives shall appoint to the ethics committee of their respective
10 house five members, not more than three of whom may be from the same
11 political party.

12 B. Each ethics committee shall propose, and each house of the
13 legislature shall adopt, not later than thirty days after the beginning of
14 each THE FIRST REGULAR legislative session, a code of ethics and conflict of
15 interest requirements as part of the rules of the respective house in the
16 same manner as other rules are adopted.

17 C. On the request of a member of the legislature or on its own
18 initiative, each ethics committee may issue advisory opinions interpreting
19 the code of ethics, conflict of interest and financial disclosure
20 requirements.

21 D. Each ethics committee shall investigate complaints and charges
22 against members of its house and, if necessary, report the results of the
23 investigation to its house with recommendations for further action.

24 E. A member is subject to punishment or expulsion as provided by
25 article IV, part 2, section 11, Constitution of Arizona, for any violation
26 of the code of ethics, conflict of interest or financial disclosure
27 requirements.
