SENATE BILL 1163

AN ACT

REPEALING SECTION 41-3004.06, ARIZONA REVISED STATUTES; AMENDING TITLE 41, CHAPTER 27, ARTICLE 2, ARIZONA REVISED STATUTES, BY ADDING SECTION 41-3014.01; RELATING TO THE BOARD OF COSMETOLOGY.

1 Be it enacted by the Legislature of the State of Arizona:

2 Section 1. Repeal

3 Section 41-3004.06, Arizona Revised Statutes, is repealed.

4 Sec. 2. Title 41, chapter 27, article 2, Arizona Revised Statutes, is
5 amended by adding section 41-3014.01, to read:

6 41-3014.01. Board of cosmetology; termination July 1, 2014

7 A. THE BOARD OF COSMETOLOGY TERMINATES ON JULY 1, 2014.

8 B. TITLE 32, CHAPTER 5 IS REPEALED ON JANUARY 1, 2015.

9 Sec. 3. Purpose

10 Pursuant to section 41-2955, subsection B, Arizona Revised Statutes,
11 the legislature continues the board of cosmetology to ensure that the public
12 is protected from the incompetent practice of cosmetology. This is achieved
13 through the establishment of minimum qualifications for entry into the
14 profession and through swift and effective discipline for those practitioners
15 who violate cosmetology statutes or rules adopted pursuant to those statutes.

16 Sec. 4. Retroactivity

17 Sections 1 and 2 of this act are effective retroactively to July 1,
18 2004.
