8 A. THE STATE BOARD OF EQUALIZATION TERMINATES ON JULY 1, 2014.
9 B. TITLE 42, CHAPTER 16, ARTICLE 4 IS REPEALED ON JANUARY 1, 2015.
10 Sec. 3. Purpose
11 Pursuant to section 41-2955, subsection B, Arizona Revised Statutes,
12 the legislature continues the state board of equalization to hear
13 administrative appeals of property tax assessed by the county assessors in
14 large counties in this state.
15 Sec. 4. Retroactivity
16 Sections 1 and 2 of this act are effective retroactively to July 1,
17 2004.
