## SENATE CONCURRENT RESOLUTION 1009

### A CONCURRENT RESOLUTION

PROPOSING AN AMENDMENT TO THE CONSTITUTION OF ARIZONA; AMENDING ARTICLE VI, SECTION 31, CONSTITUTION OF ARIZONA; RELATING TO THE JUDICIAL DEPARTMENT.

1 Be it resolved by the Senate of the State of Arizona, the House of  
2 Representatives concurring:

3 1. Article VI, section 31, Constitution of Arizona, is proposed to be  
4 amended as follows if approved by the voters and on proclamation of the  
5 Governor:

6 31. Judges pro tempore

7 Section 31. A. The legislature may provide for the  
8 appointment of members of the bar having the qualifications  
9 provided in section 22 of this article as judges pro tempore of  
10 courts inferior to the supreme court, EXCEPT THAT JUSTICES OF  
11 THE PEACE PRO TEMPORE SHALL HAVE THE SAME QUALIFICATIONS AS  
12 JUSTICES OF THE PEACE AND DO NOT HAVE TO RESIDE IN THE PRECINCT  
13 IN WHICH THE JUSTICE OF THE PEACE PRO TEMPORE IS APPOINTED TO  
14 SERVE.

15 B. When serving, any such person shall have all the  
16 judicial powers of a regular elected judge of the court to which  
17 he THE PERSON is appointed. A person so appointed shall receive  
18 such compensation as may be provided by law. The population  
19 limitation of section 10 of this article shall not apply to the  
20 appointment of judges pro tempore of the superior court.

21 2. The Secretary of State shall submit this proposition to the voters  
22 at the next general election as provided by article XXI, Constitution of  
23 Arizona.
