HOUSE BILL 2113

AN ACT

MAKING AN APPROPRIATION TO THE CORPORATION COMMISSION FOR CORPORATIONS
DIVISION STAFFING AND EXPENSES.

1 Be it enacted by the Legislature of the State of Arizona:

2 Section 1. Supplemental appropriation; corporation commission;
3 reports; exemption

4 A. In addition to the appropriation made pursuant to Laws 2004,
5 chapter 275, section 12, the sum of \$456,206 is appropriated from the public
6 access fund established by section 10-122, Arizona Revised Statutes, in
7 fiscal year 2004-2005 to the corporation commission for corporations division
8 staffing costs and related expenses.

9 B. The corporation commission corporations division shall provide a
10 monthly report for the remainder of fiscal year 2004-2005 and quarterly
11 reports for fiscal year 2005-2006 to the joint legislative budget committee
12 on the following:

13 1. The total number of filings received by the corporations division.


14 2. The total number of filings processed by the corporations division
15 and the amount of time to process the filings.

16 C. The corporation commission corporations division shall include in
17 the first monthly report required by subsection B of this section a plan for
18 resolving the backlog of corporation filings.

19 D. The appropriation made in subsection A of this section is exempt
20 from the provisions of section 35-190, Arizona Revised Statutes, relating to
21 lapsing of appropriations.
