HOUSE BILL 2125

AN ACT

AMENDING TITLE 28, CHAPTER 10, ARTICLE 4, ARIZONA REVISED STATUTES, BY ADDING SECTION 28-4415; RELATING TO MOTOR VEHICLE SALES.

1 Be it enacted by the Legislature of the State of Arizona:

2 Section 1. Title 28, chapter 10, article 4, Arizona Revised Statutes,
3 is amended by adding section 28-4415, to read:

4 28-4415. Resale of new motor vehicles

5 A MOTOR VEHICLE DEALER MAY RESELL A NEW MOTOR VEHICLE IF ALL OF THE
6 FOLLOWING APPLY:

7 1. A CERTIFICATE OF TITLE IS NOT TRANSFERRED FROM THE PERSON WHO FIRST
8 ACQUIRED THE NEW MOTOR VEHICLE FROM THE MANUFACTURER OR IMPORTER OR AGENT OF
9 THE MANUFACTURER OR IMPORTER.

10 2. THE NEW MOTOR VEHICLE IS RETURNED TO THE SELLING MOTOR VEHICLE
11 DEALER.

12 3. THE MOTOR VEHICLE DEALER GIVES WRITTEN NOTICE TO THE RETAIL
13 CONSUMER THAT THE VEHICLE WAS DELIVERED TO A PREVIOUS PURCHASER.

14 4. THE RETAIL CONSUMER SIGNS AN ACKNOWLEDGMENT OF RECEIPT OF THE
15 WRITTEN NOTICE PRESCRIBED BY PARAGRAPH 3 AND THE MOTOR VEHICLE DEALER
16 MAINTAINS A COPY OF THE ACKNOWLEDGMENT IN THE DEALER'S RECORDS.
