REPEALING SECTION 41-3005.03, ARIZONA REVISED STATUTES; AMENDING TITLE 41, CHAPTER 27, ARTICLE 2, ARIZONA REVISED STATUTES, BY ADDING SECTION 41-3015.01; RELATING TO THE BOARD OF EXECUTIVE CLEMENCY.

1 Be it enacted by the Legislature of the State of Arizona:

2 Section 1. Repeal

3 Section 41-3005.03, Arizona Revised Statutes, is repealed.

4 Sec. 2. Title 41, chapter 27, article 2, Arizona Revised Statutes, is  
5 amended by adding section 41-3015.01, to read:

6 41-3015.01. Board of executive clemency; termination July 1,  
7 2015

8 A. THE BOARD OF EXECUTIVE CLEMENCY TERMINATES ON JULY 1, 2015.

9 B. TITLE 31, CHAPTER 3 IS REPEALED ON JANUARY 1, 2016.

10 Sec. 3. Purpose

11 Pursuant to section 41-2955, subsection B, Arizona Revised Statutes,  
12 the legislature continues the board of executive clemency to recommend and  
13 grant commutations, pardons, reprieves and absolute discharge and to grant or  
14 revoke paroles.

15 Sec. 4. Retroactivity

16 Sections 1 and 2 of this act are effective retroactively to July 1,  
17 2005.
