28 contributions and assets and distribute retirement and long-term disability
29 benefits to retired members of the system and plan.
30 B. Pursuant to section 41-2955, subsection B, Arizona Revised
31 Statutes, the legislature continues the public safety personnel retirement
32 system fund manager in order to manage and invest employee and employer
33 contributions and assets and distribute retirement benefits to retired
34 members of the elected officials' retirement plan, the public safety
35 personnel retirement system and the corrections officer retirement plan.
36 Sec. 6. Retroactivity
37 Sections 1 through 4 of this act are effective retroactively to July 1,
38 2006.
