# **HOUSE BILL 2390**

AN ACT

AMENDING TITLE 41, CHAPTER 15, ARTICLE 2, ARIZONA REVISED STATUTES, BY ADDING SECTION 41-2069; RELATING TO THE DEPARTMENT OF WEIGHTS AND MEASURES.

1 Be it enacted by the Legislature of the State of Arizona:

2 Section 1. Title 41, chapter 15, article 2, Arizona Revised Statutes,  
3 is amended by adding section 41-2069, to read:

4 41-2069. Disposition of seized property

5 ONE HUNDRED EIGHTY DAYS AFTER THE FINAL DISPOSITION OF AN INVESTIGATION  
6 AND ANY ENSUING ENFORCEMENT ACTION, THE DEPARTMENT MAY DESTROY THOSE WEIGHTS,  
7 MEASURES OR DEVICES THAT ARE SEIZED PURSUANT TO SECTION 41-2065 OR 41-2066 OR  
8 TRANSFER THE ITEMS TO THE DEPARTMENT OF ADMINISTRATION FOR DISPOSITION AS  
9 STATE SURPLUS PROPERTY PURSUANT TO THE DIRECTION OF THE DEPARTMENT OF  
10 ADMINISTRATION, SURPLUS PROPERTY DIVISION.
