CHAPTER 198

**SENATE BILL 1351**

AN ACT

AMENDING SECTION 36-485, ARIZONA REVISED STATUTES; RELATING TO THE ARIZONA  
HEALTH FACILITIES AUTHORITY.

1 Be it enacted by the Legislature of the State of Arizona:

2 Section 1. Section 36-485, Arizona Revised Statutes, is amended to  
3 read:

4 36-485. Powers of board

5 The board may:

- 6 1. Adopt an official seal and alter the same at its pleasure.
- 7 2. Maintain an office.
- 8 3. Acquire any project or projects on behalf of the authority.
- 9 4. Accept grants of money or materials or property of any kind from a  
10 federal, state, county or municipal agency or others, on terms and conditions  
11 as may be imposed.
- 12 5. Waive any privilege or immunity in order to accept any grant, gift,  
13 subsidy or contribution when deemed necessary by the board.
- 14 6. Issue bonds as provided in this chapter for projects located in  
15 this state.
- 16 7. Issue bonds as provided in this chapter on behalf of a  
17 participating facility ~~that is headquartered in this state~~ for projects  
18 located outside or in this state, IF THE BOARD DETERMINES THAT THE ISSUANCE  
19 OF BONDS WILL PROVIDE A BENEFIT IN THIS STATE.
- 20 8. Act as either lessee or lessor in the manner provided in this  
21 chapter.
- 22 9. Make and enter into agreements, execute all instruments, perform  
23 all acts and do all things necessary or convenient to carry out the powers  
24 granted in this chapter.
- 25 10. Employ or contract with engineers, architects, attorneys,  
26 accountants, construction and financial experts and other persons as may be  
27 necessary in its judgment and fix their compensation.
- 28 11. Appoint employees as it deems necessary who shall serve at the  
29 pleasure of the board and receive compensation as the board shall fix.
- 30 12. Issue bonds for the purpose of refunding at or prior to maturity  
31 outstanding bonds or other indebtedness of any participating facility.
