HOUSE BILL 2782

AN ACT

MAKING SUPPLEMENTAL APPROPRIATIONS TO DEPARTMENTS OF THE STATE FOR FISCAL YEAR 2006-2007.

1 Be it enacted by the Legislature of the State of Arizona:

2 Section 1. Supplemental appropriation; department of
3 administration; tax settlement

4 The sum of \$1,937,000 is appropriated from the payroll clearing fund in
5 fiscal year 2006-2007 to the department of administration for supplemental
6 funding for a payment related to an internal revenue service tax settlement.

7 Sec. 2. Supplemental appropriation; department of
8 administration; operating expenses

9 The sum of \$1,700,000 is appropriated from the state general fund in
10 fiscal year 2006-2007 to the department of administration for supplemental
11 funding for operating costs relating to utility costs.

12 Sec. 3. Supplemental appropriation; department of economic
13 security; foster care program

14 The sum of \$19,700,000 is appropriated from the state general fund in
15 fiscal year 2006-2007 to the department of economic security for supplemental
16 funding to replace a loss in federal funds for the foster care program
17 associated with the deficit reduction act of 2005. The \$19,700,000 shall be
18 allocated to the following line items:

26 Sec. 4. Department of economic security; long-term care home
27 and community based services; supplemental
28 appropriations

29 A. The sum of \$3,000,000 in expenditure authority of federal monies is
30 appropriated in fiscal year 2006-2007 to the department of economic security
31 home and community based services line item in the long-term care cost
32 center.

33 B. The sum of \$8,800,000 is appropriated from the long-term care
34 system fund in fiscal year 2006-2007 to the department of economic security
35 home and community based services line item in the long-term care cost
36 center.

37 Sec. 5. Supplemental appropriation; state department of
38 corrections; operating expenses

39 The sum of \$9,656,000 is appropriated from the state general fund in
40 fiscal year 2006-2007 to the state department of corrections for supplemental
41 funding for operating costs relating to inmate health care.

42 Sec. 6. Supplemental appropriation; attorney general; operating
43 expenses

44 The sum of \$261,500 is appropriated from the state general fund in
45 fiscal year 2006-2007 to the attorney general - department of law for

1 supplemental funding for operating costs relating to pro rata charge
2 revenues.

3 Sec. 7. Supplemental appropriation; department of revenue;
4 litigation expenses; exemption

5 A. The sum of \$1,000,000 is appropriated from the risk management fund
6 in fiscal year 2006-2007 to the department of revenue for supplemental
7 funding for litigation expenses, including the making of expenditures and the
8 incurrence of indebtedness for external legal services hired by the
9 department of law for department of revenue matters pursuant to section
10 41-191, subsection C, Arizona Revised Statutes.

11 B. The appropriation made in subsection A of this section is exempt
12 from the provisions of section 35-190, Arizona Revised Statutes, relating to
13 lapsing of appropriations.

14 Sec. 8. Department of emergency and military affairs; project
15 challenge; appropriation; exemption

16 Notwithstanding any other law, \$500,000 of the amounts appropriated for
17 project challenge in the department of emergency and military affairs for
18 fiscal year 2005-2006 by Laws 2005, chapter 286, section 31, as exempted from
19 lapsing by Laws 2006, chapter 316, section 11, and \$500,000 of the amounts
20 appropriated for project challenge in the department of emergency and
21 military affairs for fiscal year 2006-2007 by Laws 2006, chapter 334, section
22 12, are exempt from the provisions of section 35-190, Arizona Revised
23 Statutes, relating to lapsing of appropriations, through June 30, 2008.

24 Sec. 9. Supplemental appropriation; board of respiratory care
25 examiners; increased health related expenditures;
26 other operating expenditures

27 The sum of \$30,000 is appropriated from the board of respiratory care
28 examiners fund in fiscal year 2006-2007 to the board of respiratory care
29 examiners to replace funding for higher than anticipated health-related
30 expenditures and other operating expenditures.

31 Sec. 10. Supplemental appropriation; Arizona medical board;
32 litigation expenses; exemption

33 A. The sum of \$326,000 is appropriated from the Arizona medical board
34 fund in fiscal year 2006-2007 to the Arizona medical board for supplemental
35 funding for litigation expenses.

36 B. The appropriation made in subsection A of this section is exempt
37 from the provisions of section 35-190, Arizona Revised Statutes, relating to
38 lapsing of appropriations, through June 30, 2009.
