AN ACT

AMENDING TITLE 36, CHAPTER 29, ARTICLE 1, ARIZONA REVISED STATUTES, BY ADDING SECTION 36-2905.08; RELATING TO THE ARIZONA HEALTH CARE COST CONTAINMENT SYSTEM.

1 Be it enacted by the Legislature of the State of Arizona:

2 Section 1. Title 36, chapter 29, article 1, Arizona Revised Statutes,
3 is amended by adding section 36-2905.08, to read:

4 36-2905.08. Nicotine replacement therapies; tobacco use
5 medications

6 A. NOTWITHSTANDING SECTION 36-2989, FOR CONTRACT YEARS BEGINNING
7 OCTOBER 1, 2008, THE ADMINISTRATION MAY EXPEND MONIES TO PROVIDE NICOTINE
8 REPLACEMENT THERAPIES AND TOBACCO USE MEDICATIONS TO MEMBERS ELIGIBLE
9 PURSUANT TO THIS ARTICLE OR ARTICLE 2 OR 3 OF THIS CHAPTER.

10 B. THE ADMINISTRATION SHALL NOT USE MONIES FROM THE STATE GENERAL FUND
11 FOR THE PURPOSES OF THIS SECTION.
