**SENATE BILL 1337**

AN ACT

AMENDING LAWS 2006, CHAPTER 350, SECTION 7; REPEALING LAWS 2007, CHAPTER 78, SECTION 2; REDISTRIBUTING AN APPROPRIATION; RELATING TO THE ARIZONA CENTENNIAL.

1 Be it enacted by the Legislature of the State of Arizona:

2 Section 1. Laws 2006, chapter 350, section 7 is amended to read:

3 Sec. 7. Appropriations; centennial celebration; capitol  
4 renovation; exemption

5 A. The sum of ~~\$2,500,000~~ \$500,000 is appropriated from the state  
6 general fund in fiscal year 2006-2007 ~~to the legislative council for a~~  
7 ~~statewide plan, activities and projects relating to the Arizona centennial~~  
8 ~~celebration~~ AS FOLLOWS:

9 1. \$50,000 TO THE HISTORICAL ADVISORY COMMISSION FOR THE PURPOSES  
10 PRESCRIBED IN LAWS 2005, CHAPTER 1, SECTION 3, AS AMENDED BY LAWS 2006,  
11 CHAPTER 350, SECTION 4 AND LAWS 2007, CHAPTER 78, SECTION 1.

12 2. \$450,000 TO THE LEGISLATIVE COUNCIL FOR THE COSTS OF THE DESIGN AND  
13 SITE PREPARATION OF THE RENOVATION OF THE STATE CAPITOL BUILDING, AS  
14 DESCRIBED IN SECTION 41-790, PARAGRAPH 6, SUBDIVISIONS (a), (b), (c) AND (d),  
15 ARIZONA REVISED STATUTES, AS A LASTING LEGACY ACCOMPLISHMENT TO COMMEMORATE  
16 THE CENTENNIAL.

17 B. Monies from the appropriation made in subsection A, PARAGRAPH 2 of  
18 this section shall not be spent except on an affirmative vote of the  
19 legislative council. Monies from the appropriation made in subsection A,  
20 PARAGRAPH 1 of this section ~~shall not be spent until a matching amount of~~  
21 ~~\$5,000,000~~ AND MONIES from sources other than the state of gifts, grants and  
22 donations ~~is~~ collected by the historical advisory commission ~~and~~ SHALL BE  
23 deposited in an Arizona centennial account in the office of the state  
24 treasurer. The state treasurer shall invest and divest monies in the account  
25 as provided by section 35-313, Arizona Revised Statutes, and monies earned  
26 from investment shall be credited to the account.

27 ~~C. Monies from gifts, grants and donations may be spent by the~~  
28 ~~historical advisory commission as they are collected, but an accounting shall~~  
29 ~~be made by the commission to the legislative council to determine~~  
30 ~~qualification for the state match.~~

31 ~~D.~~ C. Monies in the Arizona centennial account shall be spent and  
32 granted by the historical advisory commission only for the development and  
33 coordination of the statewide plan and the funding of activities and projects  
34 relating to the Arizona centennial celebration.

35 ~~E.~~ D. The ~~appropriation~~ APPROPRIATIONS made in subsection A of this  
36 section ~~is~~ ARE exempt from the provisions of section 35-190, Arizona Revised  
37 Statutes, relating to lapsing of appropriations until June 30, 2013.

39 Laws 2007, chapter 78, section 2 is repealed. ★

40 Sec. 3. Emergency

41 This act is an emergency measure that is necessary to preserve the  
42 public peace, health or safety and is operative immediately as provided by  
43 law.
