SENATE BILL 1180

AN ACT

REPEALING SECTION 41-3008.05, ARIZONA REVISED STATUTES; AMENDING TITLE 41, CHAPTER 27, ARTICLE 2, ARIZONA REVISED STATUTES, BY ADDING SECTION 41-3018.05; RELATING TO THE STATE LAND DEPARTMENT.

1 Be it enacted by the Legislature of the State of Arizona:

2 Section 1. Repeal

3 Section 41-3008.05, Arizona Revised Statutes, is repealed.

4 Sec. 2. Title 41, chapter 27, article 2, Arizona Revised Statutes, is
5 amended by adding section 41-3018.05, to read:

6 41-3018.05. State land department; termination July 1, 2018

7 A. THE STATE LAND DEPARTMENT TERMINATES ON JULY 1, 2018.

8 B. TITLE 37, CHAPTERS 1 AND 2 ARE REPEALED ON JANUARY 1, 2019.

9 Sec. 3. Purpose

10 Pursuant to section 41-2955, subsection B, Arizona Revised Statutes,
11 the legislature continues the state land department to have charge of and
12 control over all lands owned by this state, except lands under the specific
13 use and control of state institutions, and the resources in and on those
14 lands and to regulate the use of and access to those lands and resources as
15 prescribed by the enabling act, Constitution of Arizona and state law and to
16 perform such other functions as prescribed by law.

17 Sec. 4. Retroactivity

18 Sections 1 and 2 of this act are effective retroactively to July 1,
19 2008.




