AN ACT

REPEALING SECTION 41-3008.17, ARIZONA REVISED STATUTES; AMENDING TITLE 41, CHAPTER 27, ARTICLE 2, ARIZONA REVISED STATUTES, BY ADDING SECTION 41-3016.26; RELATING TO THE DEPARTMENT OF TRANSPORTATION.

1 Be it enacted by the Legislature of the State of Arizona:  
2 Section 1. Repeal  
3 Section 41-3008.17, Arizona Revised Statutes, is repealed.  
4 Sec. 2. Title 41, chapter 27, article 2, Arizona Revised Statutes, is  
5 amended by adding section 41-3016.26, to read:  
6 41-3016.26. Department of transportation; termination July 1,  
7 2016  
8 A. THE DEPARTMENT OF TRANSPORTATION TERMINATES ON JULY 1, 2016.  
9 B. TITLE 28 IS REPEALED ON JANUARY 1, 2017.  
10 Sec. 3. Purpose  
11 The purposes of the department of transportation include:  
12 1. Designing, constructing and maintaining the state highway system  
13 and state routes for the entire state.  
14 2. Providing for orderly registration and titling of vehicles and  
15 licensure of motor vehicle drivers.  
16 3. Assisting and promoting the aviation industry in this state.  
17 4. Providing for orderly registration and licensure of general  
18 aviation aircraft.  
19 Sec. 4. Retroactivity  
20 Sections 1 and 2 of this act are effective retroactively to July 1,  
21 2008.


