AN ACT

AMENDING SECTION 9-407, ARIZONA REVISED STATUTES; RELATING TO CITIES AND TOWNS.

1 Be it enacted by the Legislature of the State of Arizona:

2 Section 1. Section 9-407, Arizona Revised Statutes, is amended to
3 read:

4 9-407. Exchange and sale of real property; notice of intent

5 A. Any incorporated city or town may by ordinance authorize an
6 exchange of a parcel of real property OWNED BY THAT CITY OR TOWN for any
7 other parcel of real property ~~within the incorporated city or town, provided~~
8 IF the parcels of real property are of substantially equal value and the
9 exchange meets the terms and conditions ~~set forth~~ PRESCRIBED in ~~such~~ THE
10 ordinance.

11 B. Any incorporated city or town may sell a parcel of real property to
12 another political subdivision without following the procedures ~~specified~~
13 PRESCRIBED in sections 9-402 and 9-403.

14 C. A notice of intent to exchange or sell any property pursuant to
15 this section shall be published ~~in accordance with the provisions of~~ PURSUANT
16 TO section 39-204 before the exchange or sale.
