# **SENATE BILL 1134**

AN ACT

REPEALING SECTION 41-3010.25, ARIZONA REVISED STATUTES; AMENDING TITLE 41, CHAPTER 27, ARTICLE 2, ARIZONA REVISED STATUTES, BY ADDING SECTION 41-3019.01; RELATING TO THE COMMISSION FOR POSTSECONDARY EDUCATION.

1 Be it enacted by the Legislature of the State of Arizona:  
2 Section 1. Repeal  
3 Section 41-3010.25, Arizona Revised Statutes, is repealed.  
4 Sec. 2. Title 41, chapter 27, article 2, Arizona Revised Statutes, is  
5 amended by adding section 41-3019.01, to read:  
6 41-3019.01. Commission for postsecondary education; termination  
7 July 1, 2019  
8 A. THE COMMISSION FOR POSTSECONDARY EDUCATION TERMINATES ON JULY 1,  
9 2019.  
10 B. TITLE 15, CHAPTER 14, ARTICLE 5 IS REPEALED ON JANUARY 1, 2020.  
11 Sec. 3. Purpose  
12 Pursuant to section 41-2955, subsection B, Arizona Revised Statutes,  
13 the legislature continues the commission for postsecondary education to:  
14 1. Conduct, supervise and coordinate the review of public and private  
15 postsecondary education institutions in this state to determine their  
16 eligibility for student financial aid monies.  
17 2. Administer specifically identified federal and state financial aid  
18 programs.  
19 3. Provide a forum to public and private postsecondary education  
20 institutions for discussion of issues of mutual interest.  
21 4. Coordinate and promote studies of interest to postsecondary  
22 institutions.  
23 5. Provide information to the public on postsecondary education  
24 opportunities in this state.
