## **SENATE BILL 1318**

AN ACT

AMENDING SECTIONS 37-171 AND 37-173, ARIZONA REVISED STATUTES; AMENDING TITLE 37, CHAPTER 1.2, ARTICLE 1, ARIZONA REVISED STATUTES, BY ADDING SECTIONS 37-177 AND 37-178; RELATING TO GEOSPATIAL DATA AND GEOGRAPHIC INFORMATION.

1 Be it enacted by the Legislature of the State of Arizona:

2 Section 1. Section 37-171, Arizona Revised Statutes, is amended to  
3 read:

4 37-171. Definitions

5 In this chapter, unless the context otherwise requires:

6 1. "Administrator" means the administrator of the division.

7 ~~2. "Remote sensing" means the science of measurement and  
8 interpretation of both conventional aerial photography and space imagery.~~

9 ~~3. "Remote sensing techniques" means the processing of data to allow  
10 the interpreter to obtain useful information from remote sensing devices.~~

11 2. "GEOGRAPHIC INFORMATION SYSTEM" MEANS COMPUTER-BASED TECHNOLOGIES  
12 FOR STORING, MANIPULATING AND ANALYZING GEOSPATIAL DATA.

13 3. "GEOSPATIAL DATA" MEANS DIGITAL DATA USING GEOGRAPHIC OR PROJECTED  
14 MAP COORDINATE VALUES, IDENTIFICATION CODES AND ASSOCIATED DESCRIPTIVE DATA  
15 TO LOCATE AND DESCRIBE BOUNDARIES OR FEATURES ON, ABOVE OR BELOW THE SURFACE  
16 OF THE EARTH OR CHARACTERISTICS OF THE EARTH'S INHABITANTS OR ITS NATURAL OR  
17 HUMAN-CONSTRUCTED FEATURES.

18 4. "PUBLIC AGENCY" MEANS ANY AGENCY OR INSTRUMENTALITY OF THE UNITED  
19 STATES, THIS STATE, ANOTHER STATE, A REGIONAL COUNCIL OF GOVERNMENTS IN THIS  
20 STATE, AN INDIAN TRIBE, NATION, COMMUNITY OR BAND, ANY POLITICAL SUBDIVISION  
21 OF THIS STATE OR ANOTHER STATE OR ANY FOREIGN COUNTRY.

22 ~~4.~~ 5. "Resource analysis division" or "division" means the resource  
23 analysis division of the state land department.

24 Sec. 2. Section 37-173, Arizona Revised Statutes, is amended to read:

26 The division shall:

27 1. Establish a clearinghouse of information and a central repository  
28 for ~~map and imagery products and digital cartographic data~~ GEOSPATIAL DATA  
29 AND STATEWIDE GEOGRAPHIC INFORMATION SYSTEM SERVICES.

30 2. Provide a- geographic information system SERVICES AND GEOSPATIAL  
31 DATA for the state land department and other public agencies in this state.  
32 ~~The system shall be capable of input, processing, display, compositing,  
33 analysis, synthesis and manipulation of data from maps, aerial photos,  
34 orthophotos, remote sensing devices and other spatial data sources. The  
35 division shall provide training and consultation in the use of the system,  
36 related technical assistance and limited production services to system users.~~

38 time by remote sensing techniques.~~

39 3. FACILITATE THE SHARING OF GEOSPATIAL DATA AND GEOGRAPHIC

1           Sec. 3. Title 37, chapter 1.2, article 1, Arizona Revised Statutes, is  
2 amended by adding sections 37-177 and 37-178, to read:

3           37-177. Arizona geographic information council

4           A. THE ARIZONA GEOGRAPHIC INFORMATION COUNCIL IS ESTABLISHED IN THE  
5 DEPARTMENT CONSISTING OF THE FOLLOWING MEMBERS WHO ARE APPOINTED BY THE  
6 GOVERNOR:

- 7           1. EIGHTEEN MEMBERS REPRESENTING STATE AGENCIES AND INSTRUMENTALITIES.
- 8           2. SIX MEMBERS REPRESENTING FEDERAL GOVERNMENTAL AGENCIES.
- 9           3. ONE MEMBER REPRESENTING A STATEWIDE ASSOCIATION OF COUNTY  
10 GOVERNMENTS.
- 11           4. ONE MEMBER REPRESENTING A STATEWIDE ASSOCIATION OF MUNICIPAL  
12 GOVERNMENTS.
- 13           5. SIX MEMBERS REPRESENTING GEOGRAPHIC INFORMATION SYSTEMS CONSORTIA  
14 OR LOCAL GOVERNMENTS.
- 15           6. ONE MEMBER REPRESENTING AN ARIZONA INDIAN TRIBAL NATION.
- 16           7. ONE MEMBER REPRESENTING A PROFESSIONAL GEOSPATIAL ORGANIZATION.
- 17           8. ONE MEMBER REPRESENTING THE PRIVATE SECTOR.

18           B. THE GOVERNOR SHALL APPOINT MEMBERS OF THE COUNCIL FOR STAGGERED  
19 THREE YEAR TERMS OF OFFICE, BUT THE GOVERNOR MAY REMOVE A MEMBER FOR CAUSE.  
20 VACANCIES SHALL BE FILLED FOR AN UNEXPIRED TERM IN THE SAME MANNER AS  
21 ORIGINAL APPOINTMENTS. THE COUNCIL SHALL ANNUALLY ELECT A CHAIRPERSON,  
22 VICE-CHAIRPERSON AND OTHER OFFICERS IT CONSIDERS NECESSARY.

23           C. MEMBERS OF THE COUNCIL ARE NOT ELIGIBLE TO RECEIVE COMPENSATION,  
24 BUT, SUBJECT TO THE AVAILABILITY OF MONIES, ARE ELIGIBLE TO RECEIVE  
25 REIMBURSEMENT OF EXPENSES PURSUANT TO TITLE 38, CHAPTER 4, ARTICLE 2.

26           D. THE COUNCIL SHALL:

- 27           1. ADVISE THE ARIZONA STATE CARTOGRAPHER'S OFFICE ON MATTERS RELATED  
28 TO GEOSPATIAL DATA SHARING AND APPROPRIATE STRATEGIES TO SUPPORT A GEOSPATIAL  
29 CLEARINGHOUSE AND STATEWIDE GEOGRAPHIC INFORMATION SYSTEM.
- 30           2. FACILITATE INTERAGENCY COORDINATION FOR THE PURPOSE OF GEOSPATIAL  
31 DATA SHARING AND SUPPORTING A GEOSPATIAL CLEARINGHOUSE, A STATEWIDE  
32 GEOGRAPHIC INFORMATION SYSTEM AND LOCATION-BASED SERVICES THAT ENHANCE AND  
33 SUPPORT FEDERAL, STATE AND LOCAL GOVERNMENT BUSINESS SYSTEMS, INCLUDING  
34 EMERGENCY PREPAREDNESS AND OTHER DISASTER MITIGATION RESPONSE SYSTEMS.
- 35           3. COLLECT INFORMATION ON USER REQUIREMENTS ON MATTERS RELATED TO  
36 GEOGRAPHIC INFORMATION SYSTEMS, GEOSPATIAL DATA, TECHNOLOGIES, PRODUCTS,  
37 SERVICES, STANDARDS, PROGRAMS AND ACTIVITIES AND PRIORITIZE THOSE  
38 REQUIREMENTS TO THE ARIZONA STATE CARTOGRAPHER'S OFFICE, THE UNITED STATES  
39 GEOLOGICAL SURVEY AND OTHER PRODUCERS OF GEOSPATIAL DATA.
- 40           4. SERVE AS A FORUM TO FACILITATE INFORMATIONAL EXCHANGE BETWEEN  
41 FEDERAL, STATE, TRIBAL, REGIONAL AND LOCAL GOVERNMENTS, THE PRIVATE SECTOR  
42 AND PROFESSIONAL ASSOCIATIONS.
- 43           5. APPOINT TECHNICAL COMMITTEES AS NECESSARY.

1           37-178. Geospatial data sharing

2           A. A PUBLIC AGENCY THAT SHARES GEOSPATIAL DATA WITH ANOTHER PUBLIC  
3 AGENCY MAY:

4           1. SHARE GEOSPATIAL DATA WITHOUT ENTERING INTO A WRITTEN AGREEMENT  
5 WITH THE OTHER PUBLIC AGENCY.

6           2. SHARE GEOSPATIAL DATA OF WHICH IT IS THE CUSTODIAN.

7           3. RETAIN CUSTODIAL OWNERSHIP OF ANY GEOSPATIAL DATA PROVIDED TO OTHER  
8 PUBLIC AGENCIES.

9           4. PROHIBIT SHARED DATA FROM BEING REDISTRIBUTED BY RECIPIENT PUBLIC  
10 AGENCIES IF NOTIFICATION OF THE PROHIBITION IS GIVEN.

11           B. A PUBLIC AGENCY THAT SHARES GEOSPATIAL DATA MAY EXEMPT THE DATA  
12 FROM COMMERCIAL USE FEES PRESCRIBED IN SECTION 39-121.03, SUBSECTION A,  
13 PARAGRAPH 3.

14           C. A PUBLIC AGENCY THAT SHARES GEOSPATIAL DATA OF WHICH IT IS THE  
15 CUSTODIAN IS NOT LIABLE FOR ERRORS, INACCURACIES OR OMISSIONS AND SHALL BE  
16 HELD HARMLESS FROM AND AGAINST ALL DAMAGE, LOSS OR LIABILITY ARISING FROM ANY  
17 USE OF GEOSPATIAL DATA THAT IS SHARED.

18           D. A PUBLIC AGENCY THAT SHARES GEOSPATIAL DATA OR RECEIVES SHARED  
19 GEOSPATIAL DATA MAY WITHHOLD THE SHARED DATA FROM PUBLIC DISCLOSURE IF THE  
20 DATA CONSIST OF CRITICAL INFRASTRUCTURE INFORMATION AS DEFINED IN SECTION  
21 41-1801.

22           Sec. 4. Initial members of the Arizona geographic information  
23 council

24           A. Notwithstanding section 37-177, Arizona Revised Statutes, as added  
25 by this act, the incumbent members of the Arizona geographic information  
26 council, established by executive order, are entitled to continue to serve as  
27 members of the council as established by this act.

28           B. The governor shall make all additional and subsequent appointments  
29 as prescribed by section 37-177, Arizona Revised Statutes, as added by this  
30 act.
