REPEALING SECTION 41-3010.14, ARIZONA REVISED STATUTES; AMENDING TITLE 41, CHAPTER 27, ARTICLE 2, ARIZONA REVISED STATUTES, BY ADDING SECTION 41-3020.14; RELATING TO THE JOINT LEGISLATIVE BUDGET COMMITTEE.

3 Section 41-3010.14, Arizona Revised Statutes, is repealed.
4 Sec. 2. Title 41, chapter 27, article 2, Arizona Revised Statutes, is
5 amended by adding section 41-3020.14, to read:
6 41-3020.14. Joint legislative budget committee; termination
7 July 1, 2020
8 A. THE JOINT LEGISLATIVE BUDGET COMMITTEE TERMINATES ON JULY 1, 2020.
9 B. TITLE 41, CHAPTER 7, ARTICLE 10 IS REPEALED ON JANUARY 1, 2021.
10 Sec. 3. Purpose
11 Pursuant to section 41-2955, subsection B, Arizona Revised Statutes,
12 the legislature continues the joint legislative budget committee to ascertain
13 facts and make recommendations to the legislature concerning fiscal matters.
14 Sec. 4. Retroactivity
15 Sections 1 and 2 of this act are effective retroactively to July 1,
16 2010.
