# HOUSE BILL 2423

AN ACT

AMENDING SECTIONS 42-17103 AND 42-17104, ARIZONA REVISED STATUTES; RELATING TO COUNTY AND MUNICIPAL BUDGET PROCEEDINGS.

1 Be it enacted by the Legislature of the State of Arizona:

2 Section 1. Section 42-17103, Arizona Revised Statutes, is amended to  
3 read:

4 42-17103. Publication of revenues and estimates of expenses and  
5 notice of public hearing

6 A. The governing body of each county, city or town shall publish the  
7 estimates of REVENUES AND expenses, or a summary of the ~~estimate~~ ESTIMATES of  
8 REVENUES AND expenses, and a notice of a public hearing ~~and special meeting~~  
9 of the governing body to hear taxpayers and make tax levies at designated  
10 times and places. The summary shall set forth ~~sources and uses of funds, and~~  
11 ~~include consolidated revenues and expenditures by category, department and~~  
12 ~~fund~~ THE TOTAL ESTIMATED REVENUES AND EXPENDITURES BY FUND TYPE, truth in  
13 taxation calculations, and primary and secondary property tax levies FOR ALL  
14 DISTRICTS. A complete copy of the ~~estimate~~ ESTIMATES of REVENUES AND  
15 expenses shall be made available at the city, town or county libraries, and  
16 city, town or county administrative offices AND SHALL BE POSTED ON THE  
17 OFFICIAL WEBSITES.

18 B. The SUMMARY OF estimates and notice, TOGETHER WITH THE LIBRARY  
19 ADDRESSES AND WEBSITES WHERE THE COMPLETE COPY OF ESTIMATES MAY BE FOUND,  
20 shall be published once a week for at least two consecutive weeks after the  
21 estimates are tentatively adopted in the official newspaper of the county,  
22 city or town, if there is one, and, if not, in a newspaper of general  
23 circulation in the county, city or town.

24 C. If a truth in taxation notice and hearing is required under section  
25 42-17107, the governing body may combine the notice under this section with  
26 the truth in taxation notice.

27 Sec. 2. Section 42-17104, Arizona Revised Statutes, is amended to  
28 read:

29 42-17104. Public hearing on expenditures and tax levy

30 A. The governing body of each county, city or town shall hold a public  
31 hearing ~~and special meeting~~ on or before the fourteenth day before the day on  
32 which it levies taxes as stated in the notice under section 42-17103. Any  
33 taxpayer may appear and be heard in favor of or against any proposed  
34 expenditure or tax levy.

35 B. If a truth in taxation notice and hearing is required under section  
36 42-17107, the governing body may combine the hearing under this section with  
37 the truth in taxation hearing.
