REPEALING SECTION 41-3010.21, ARIZONA REVISED STATUTES; AMENDING TITLE 41, CHAPTER 27, ARTICLE 2, ARIZONA REVISED STATUTES, BY ADDING SECTION 41-3020.21; RELATING TO THE STATE AUDITOR GENERAL.

2 Section 1. Repeal
3 Section 41-3010.21, Arizona Revised Statutes, is repealed.
4 Sec. 2. Title 41, chapter 27, article 2, Arizona Revised Statutes, is
5 amended by adding section 41-3020.21, to read:
6 41-3020.21. State auditor general; termination July 1, 2020
7 A. THE STATE AUDITOR GENERAL TERMINATES ON JULY 1, 2020.
8 B. TITLE 41, CHAPTER 7, ARTICLES 10.1 AND 10.2 ARE REPEALED ON JANUARY
9 1, 2021.
10 Sec. 3. Purpose
11 Pursuant to section 41-2955, subsection B, Arizona Revised Statutes,
12 the legislature continues the state auditor general to conduct sunset reviews
13 of agencies, audits, special audits and postaudits of units or government and
14 to report the results pursuant to law.
15 Sec. 4. Retroactivity
16 Sections 1 and 2 of this act are effective retroactively to July 1,
17 2010.
