REPEALING SECTION 41-3010.20, ARIZONA REVISED STATUTES; AMENDING TITLE 41, CHAPTER 27, ARTICLE 2, ARIZONA REVISED STATUTES, BY ADDING SECTION 41-3020.20; RELATING TO THE RESIDENTIAL UTILITY CONSUMER OFFICE.

1 Be it enacted by the Legislature of the State of Arizona:
2 Section 1. Repeal
3 Section 41-3010.20, Arizona Revised Statutes, is repealed.
4 Sec. 2. Title 41, chapter 27, article 2, Arizona Revised Statutes, is
5 amended by adding section 41-3020.20, to read:
6 41-3020.20. Residential utility consumer office; termination
7 July 1, 2020
8 A. THE RESIDENTIAL UTILITY CONSUMER OFFICE TERMINATES ON JULY 1, 2020.
9 B. TITLE 40, CHAPTER 2, ARTICLE 11 IS REPEALED ON JANUARY 1, 2021.
10 Sec. 3. Purpose
11 Pursuant to section 41-2955, subsection B, Arizona Revised Statutes,
12 the legislature continues the residential utility consumer office to protect
13 the interests of consumers regarding residential utility costs, charges and
14 procedures.
15 Sec. 4. Retroactivity
16 Sections 1 and 2 of this act are effective retroactively to July 1,
17 2010.
