CHAPTER 164

SENATE BILL 1171

AN ACT

AMENDING TITLE 27, CHAPTER 6, ARTICLE 4, ARIZONA REVISED STATUTES, BY ADDING SECTION 27-1277; RELATING TO AGGREGATE MINED LAND RECLAMATION.

1 Be it enacted by the Legislature of the State of Arizona:

2 Section 1. Title 27, chapter 6, article 4, Arizona Revised Statutes,
3 is amended by adding section 27-1277, to read:

4 27-1277. Annual status report

5 A. WITHIN SIXTY DAYS AFTER THE ANNIVERSARY DATE OF APPROVAL OF EACH
6 RECLAMATION PLAN THE OWNER OR OPERATOR SHALL SUBMIT TO THE DIVISION A STATUS
7 REPORT FOR THE PRECEDING YEAR.

8 B. THE REPORT SHALL BE IN A FORM PRESCRIBED BY THE STATE MINE
9 INSPECTOR AND SHALL INCLUDE:

10 1. THE ACREAGE OF SURFACE DISTURBANCE DURING THE REPORTING YEAR AND
11 THE TOTAL ACREAGE OF SURFACE DISTURBANCE AT THE MINING FACILITY.

12 2. THE ACREAGE OF RECLAMATION CONDUCTED DURING THE REPORTING YEAR AND
13 THE TOTAL ACREAGE OF RECLAMATION AT THE MINING FACILITY.

14 3. THE STATUS OF THE AGGREGATE MINING OPERATION AT THE END OF THE
15 REPORTING YEAR.

16 4. ANY CHANGE IN THE NAMES AND ADDRESSES OF THE OWNER, OPERATOR AND
17 THE REGULATORY CONTACT.

18 C. THE INSPECTOR MAY REQUEST FURTHER INFORMATION TO SUPPLEMENT OR
19 CLARIFY THE REPORT, BUT IF THE INSPECTOR DOES NOT RESPOND WITHIN THIRTY DAYS
20 AFTER RECEIVING THE REPORT, IT IS CONSIDERED TO BE ACCEPTED FOR THE PURPOSES
21 OF THIS SECTION.

22 Sec. 2. Application

23 The reporting requirements prescribed by section 27-1277, Arizona
24 Revised Statutes, as added by this act, apply with respect to all existing
25 and future aggregate mining plans from and after the effective date of this
26 act.
